2.5% of monthly income at first charge for FS-1 and increasing .16% at every level. Use FS-1 amounts in each FS column beginning at 150% of FPG

To arrive at Annual Gross Income:

1. Take Poverty Level * 1.5=1st chargeable rate
2. Poverty level increment amount for each additional family member/2=increments to use
3. 1st chargeable rate+increments to use=Annual Gross Income

Example

1. 12490 * 1.5=18735
2. 4420/2=2210
3. 18735+2210=20945
